Letters from the Association's attorney have been sent to Oakpointe Builders. The lawyer does agree that we have the grounds to sue for unpaid assessments, but in any lawsuit there is a risk. Sloan would like to negotiate with them and give them some type of break, Tony agrees but would like to make sure they sign and agree to pay us without going to court. If they do not agree to pay then we need to take them to court.

 - The board was presented with bids to replace the fencing. Sloan suggested that the ARC take on a special project and research alternative fencing, finding three choices to best suite Sunrise. The ARC should take into consideration, the wind, graffiti, longevity, rain and then present to the board on what would be the right fence for the community.
- b) <u>Abandoned Car in Undeveloped Property</u> Homeowner has now moved his abandoned car to undeveloped property in Sunrise. Gina has looked into it and we will be having it towed and it will be charged to the owner of the vehicle.
- c) <u>Clubhouse Use for Fundraising</u>—The board feels we need to look into clarifying our rules. There should be no fundraising at the Clubhouse; if we make an exception we will be opening ourselves up to a lot of problems.
