Their concern was wind and this is why they chose shadow board fencing. He stated that the shadow board design works well. Sloan asked if they applied for the fence through ARC and he stated they had not. The board stated the shadow board fencing does not follow the ARC guidelines, and asked them to re-submit a new plan.

Rick Seddon stated along the boulevard, the 4 foot fence along the back shouldn't need ARC approval because it is not a common area fence. The Board stated any fence along a major roadway is a common area fence and needs ARC approval.

Roger Herbert from HC Homes stated he had applied for a revision to the fence, but the ARC denied it because of the 4x4 post and other elements that did not match common area fencing. He also stated he would provide an engineering report to the Board supporting shadow board fencing based on the wind on the hillside. He said SMAs guidelines for fences in that location would fail due to high winds. When Roger asked about the stain color, the Board noted the current stain color for Emerald Pointe was approved as a variance.

The board asked Roger Herbert to provide the following information:

- 1. Send engineering report that supports stability of the fence.
- 2. Their proposal for what they think would work; keeping in mind it must look the same as the current common area fences.

Alex Kerth and Tristin Mueller spoke to the board about the recent vandalism to the grass at the SMA Park, Silverwood Park, and SDC property across the street from ERHS. Parcels 6020500410, 6021000471 and 0419351017. They apologized for their actions. The board stated they would decide what course of action would be taken and get back to their parents.
