1. Call to Order- Kathy Fewins called meeting to order at 7:02PM

2. Introductions- Board Members, CDC Management and vendor's introduced.

3. Proof of Notice of Meeting- Notice was mailed 2/29/08. - Declaration of Mailing will be viewable in the office.

a. Board of Directors Structure and Update-

2. Class B (was not present at the 2007 annual meeting) Declarant appointed Troy Dunlap for the 2007 year

ii. For the year 2008:

1. Class A continues to be represented by Ed Moersch

2. Class B (was not present at the 2008 annual meeting) The Declarant appointed Troy Dunlap for the 2008 year.

3. Class C appointed Sloan Clack for a 2 year term 2008 - 2010, Eric Corliss for a 2 year term 2008 - 2010 and Rae Noehl for a 1 year term 2008 - 2009

b. By-Law Amendments

i. The proposed Bylaw Amendment passed. The number of directorsidentified in the Bylaws will now match the CC&R's allowing 5-7 Board members

ii. Electronic Notice and Voting Policy- Amendment passed. This allows homeowners to choose to receive electronic notification as an acceptable

form of voting and notification.

c. 2007 Audit Waiver Election-Audit process reviewed, homeowners voted, and approved with majority that a full Audit take place for the 2007-2008 year. Board will obtain bids and proceed with audit.

3. 2008 Goals

4. Puyallup School District – Karen Hansen, Communications Director-Rudy Fyles presented construction of the new Glacier View Junior High, school to open fall of 2008. Crosswalks will be improved, are currently under construction- intersection to have signal- Public Works in process Resource Officers are in place to assist with speeding/traffic enforcement.

5. Community Safety – Paul Pastor, Pierce County Sheriff-Speed patrols are in force, number of Meth Labs in Pierce Co reduced from 350-27. Encouraged homeowners to turn on lights, and be vigilant.

- 6. Development Activity Kathy Fewins, Investco Financial Corp-Development of 184th is responsibility of SDC, 180th will not be built out this year due to road permit timeline. Destiny Church site 20 acres is in appeals once again. SDC is obtaining preliminary plat for Deer Hollow and Community 5. Southwood Estates still has 40 lots for sale. No plans to develop any lots in 2008. Orting School District is considering an elementary school in Uplands. Emerald Ridge will consist of 330 single detached houses and 331 multi-family. Final plat in 2008.
- 7. Landscape & Maintenance- Moss control and aerating will take place in the next upcoming week, the first planting will be the 1st week of April. The Board is making a decision on whether or not to replace the tree's in the median. Southwood Estates landscaping needs Board approval as well working with Puget Sound Energy for power to the sprinkler system.

ii. Committees- Nancy announced the first Committee recruits will meet in April.

- ARC Guidelines are viewable on the website. 4/3 ARC will have completed the 30 day homeowner review period. Board will review suggested changes and new guidelines will be posted after Board finalization.

- a. Steve Mortensen, Can we eliminate Class B? Will get back to you with answer from outside council.
- b. Harold Leimohn, Amendment 1 bylaws what was the process, how did this happen? Sloan replied- No comments or concerns received on the amendment, therefore it passed by means of no homeowner objection.
- c. Steve Mortensen- Comment for the good of the order, thank you Crime Task Force. Question #7 need more clarification, he is not convinced CDC \$1.35 apartment fee is worthy. –

Sandi responded, Common areas, marketing ability of apartments were all part of the fee in the contract and that if they were not included the fee would have to be spread across all the homeowners.

- c. Lee Anne Kerlin, What does CDC do for the Condo's? Condo's pay more than just HOA dues they have additional cost. Sandi replied, There is a charge per unit breakdown that was discussed.
- d. Steve Mortensen, When the CDC contract is up, consider to renegotiate the cost of charges for apartments and condos.
- e. John Mejia, What is the process for the Class elections? Why was no one else was offered/approached to represent Class B? Sloan answered, the class B representative was not present at the 2008 annual meeting. The Declarant appointed Troy Dunlap to the Board to as a Class B representative. If the Class B representative is not present at the next meeting, that Board position will again become available for the Declarant to fill with a representative. If there are homeowners interested in being on the board please let the SMA office or the Board know. Class A will hold elections for the Class A position in 2009f.
