4. Presidents Report

a) New Sunrise Blvd Irrigation and Sidewalks update

It is recommended to move forward with the previously approved irrigation installation and postpone the sidewalk portion – Angie is requested to notify Total Grounds Management to begin project by calling for utility locate.

5. Financial Information and Community Updates

a) December 2010 Financial Information – Angie Orr presented the financial information for the end of the year, after reminding the Board that November financials had been emailed to them previously. Discussion included 2010 Accounts Receivable status and given the economic challenges, the friendly approach was most effective.

- b) Review of 2010 Collection Accounts A summary of 2010 accounts in collections was presented including the Board approved write offs.
  - 1. North Rim, Lot 1, 2010 Chapter 7 Discharge SMA had to write off \$4,097.17 due to Chapter 7 filing. Homeowner paid to SABA the remaining balance of \$461.00. Sloan requested Angie discuss with SABA that they were responsible to track the bankruptcy. SMA would not have assigned the year end balance to collection had they been informed and feel we should not forfeit 50% of amount recovered to SABA.

- c) <u>Review of 2010 ARC Applications and Responses</u> Spreadsheet of 2010 ARC was presented to the Board for review. Information is on file in Association office.
- d) <u>Review of 2010 Violations & Responses</u> Spreadsheet of 2010 Violations was presented to the Board for review. Information is on file in Association office.

e) Projects in Process or Recently Completed

Community Center Drainage Repairs – The Board previously authorized TGM's bid.
The work is now completed. Angie can request additional proposal for the other side
of the community center near the tennis court.

- 2. Monument Signs Cold weather damaged the adhesive and the majority of signs fell. Spectrum Signs has picked the signs up and will re-adhere in warmer weather.
- 3. Entry Pond lighting Repairs Totem Electric is waiting for the new lighting kit to be delivered. They will schedule installation in conjunction with TGM.
- 4. Savannah Ridge Tract A Maintenance Work started today, January 19, 2011 by TGM Contract presented for Sloan Clack's original signature.

- a) William West (SMA owned property) The outstanding balance is now about \$1,000 plus dues and late fees that may be collected in the next few weeks. There has been no news from Chase Bank about the foreclosure status of the property.
- b) <u>Spring Water on 122<sup>nd</sup> St near Deer Ridge</u> Photos and correspondence have been sent to Judy to provide to attorney for review and suggestions on how to proceed.
- c) <u>CC&R Rewrite update</u> The Declarant attorney is in the process of reviewing. The HOA attorney has not yet received documents to review.
- d) Website Renovation update In Progress Working on a fee schedule for advertising to propose to the Board at the next meeting.
- e) North Rim Irrigation In Progress Still waiting for possible water source. There has been no contact with resident on West side of pond yet.

- b) Mike Carver planting request at the Meadows Mr. Carver's request is to enhance the common area of the Community Center park at his own cost. He will purchase the trees and is asking that the Labor be provided by the HOA via TGM using their labor hours.
